## 5 Web Analysis Using Google Analytics

This website uses Google Analytics, a web analysis service of Google LLC (USA).

Purpose of this data processing:

- There is **no creation** of user profiles

Legal basis:

- Art. 31, para. 2, lit. a, Swiss DPA (performance of a contract, if relevant)

You can revoke your consent to receiving the newsletter at any time.

## 7 Embedded Content and Third-Party Services

On our website we embed the services of the following third-party providers:
